

**** Changes to New York Record Searches ****

Effective July 14, 2003, per section 14 of Assembly Bill A02106, the New York Office of Court Administration (OCA) of the NY Unified court System is expanding its criminal records history search. What was formerly a single county search (with a \$16 court fee per county) from one of 13 counties in the New York City area will become a statewide, all counties inclusive search. Instead of a \$16 additional court fee for each county or borough searched, the court fee will now charge \$55 when any one of the 13 counties is searched. The counties involved are: Bronx, Dutchess, Erie, Kings, Nassau, New York, Orange, Putnam, Queens, Richmond, Rockland, Suffolk, and Winchester.

Effective July 21, 2003 New York's OCA has added more counties in addition to the 13 boroughs to their statewide search. Their main objective is to phase out all public access at the individual county level but have no certain time limits. Also, many jurisdictions are still debating whether or not to rescind access at the county level and refer access to the OCA. The new counties added are Allegany, Cayuga, Courtland, Delaware, Hamilton, Montgomery, Orleans, and Tioga.

Effective November 12, 2003, they have added 11 more counties to their statewide search. The counties added are Chenango, Fulton, Genesee, Niagara, Ontario, Seneca, St Lawrence, Stueben, Sullivan, Wayne, and Wyoming.

This change could be good news or bad news, depending on your criminal search requirements. The new program will benefit those companies who require a statewide search when available; one was not previously available in New York. Also, some businesses are required to search all five New York City boroughs when the subject has a history in any one of them. Instead of paying an additional \$16 for each of the five borough (\$80), they will now cost only \$55, and in addition they will receive statewide coverage. On the other hand, many companies normally choose to search criminal records in only one county. For those companies who hire heavily in the New York City area, the fee increase will be strongly felt.
